LIMITED LIFETIME WARRANTY

FOR VIPER® CSX CRAWL SPACE VAPOR BARRIERS

ISI Building Products warrants that crawl space vapor barriers manufactured by the Company will be free from defects in material and workmanship, under normal and proper use, storage, and operating conditions, for the life of the structure. The Company will at its option, replace or repair defective product returned to the Company, or if repair and replacement are impossible, refund the purchase price. For purposes of this Warranty, "life of the structure" means the period of time beginning on the date of shipment to the original purchaser and continuing for as long as the building remains in good repair.

This limited warranty shall be void in the event of:

- (i) **Improper, negligent, abusive or other misuse of the products not intended or authorized in writing by the Company.**
- (ii) **Alteration or unauthorized repairs to product which, in the Company's sole judgment, would affect the performance, safety or reliability of the products.**
- (iii) **Failure to give notice, in writing, to the Company of the defect within ten days of discovery of the defect.**

The Purchaser will take complete responsibility for the installation of the products of the Company, and will abide by all National and Local codes and laws; (codes and laws may vary in geographical location).

The Company may render advice, recommendations or opinions as to the application, installation or operation of its products, but such advice, recommendations or opinions shall be at Purchaser's own risks and shall not give rise to liability based upon reliance on such advice, recommendations or opinions rendered by the Company.

Submit all warranty claims in writing within ten days of the defect discovery. Include a brief description of damage, a copy of dated sales receipt, invoice and evidence of installation date and send to:
